SECTION 1. That Section 175-31, Schedule XX (175-95) of Ordinance No. 1960 be and the same is amended and supplemented so as to rescind a "HANDICAPPED PARKING ONLY" zone restriction on the following roadway:

- a) At 332 Darby Road, one space, in front of residential dwelling.

SECTION 2. That Section 175-31, Schedule XX (175-95) of Ordinance No. 1960 be and the same is amended and supplemented so as to establish a "HANDICAPPED PARKING ONLY" zone restriction on the following roadway:

- a) At 523 Woodland Drive, one space, in front of residential dwelling.
This space is for resident residing at 510 Woodland Drive.

SECTION 3. That Section 175-27, Schedule XVI (175-91) of Ordinance No. 1960 be and the same is amended and supplemented so as to establish "NO PARKING HERE TO CORNER" restriction on the following roadway:

- a) On Woodbine Road, west side, from Washington Avenue approximately 30 feet south thereof.

SECTION 4. That Section 175-31, Schedule XVI (175-91) of Ordinance No. 1960 be and the same is amended and supplemented so as to establish a "HANDICAPPED PARKING ONLY" zone restriction on the following roadway:

- a) 169 Juniper Road, one space, in front of residential dwelling.

SECTION 5. Upon effective date of this ordinance, the Highway Department shall install appropriate signs in the said sections or zones giving notice of the regulations aforesaid.

SECTION 6. Any ordinance or part of ordinance to the extent that it is inconsistent herewith is hereby repealed.

AN ORDINANCE OF THE TOWNSHIP OF HAVERFORD, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, FURTHER AMENDING AND SUPPLEMENTING ORDINANCE NO. 1960, ADOPTED JUNE 30, 1986 AND KNOWN AS THE "GENERAL LAWS OF THE TOWNSHIP OF HAVERFORD", AMENDING CHAPTER 130, PEDDLING AND SOLICITING, AS SET FORTH HEREIN.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Haverford, County of Delaware, Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same:

ARTICLE I. REGULATORY AMENDMENTS

A. Chapter 130, Section 130-1, Definitions, is hereby amended as follows:

The word SOLICITING is hereby defined as follows:

- (a) SOLICITING (COMMERCIAL) - The seeking or taking of contracts or orders for any goods, wares or merchandise for future delivery, or for services performed for the homeowner by a private individual or for-profit corporation, from house-to-house or from a fixed location within the Township.
- (b) SOLICITING (CHARITABLE) - An organization registered with the Commonwealth of Pennsylvania, Department of State, Bureau of Charitable Organizations for the purpose of soliciting membership, money and/or property by or on behalf of charitable organizations, from house-to-house or from a fixed location within the Township.

The word TOWNSHIP is hereby defined as follows:

TOWNSHIP - The Township of Haverford, Delaware County, Pennsylvania.

B. Chapter 130, Section 130-3, Application procedure, is hereby amended by the addition of the following:

- D. Applications for charitable solicitation shall include a copy of a current certification by the Bureau of Charitable Organizations from the Commonwealth of Pennsylvania.

- C. Chapter 130, Section 130-11, Permitted hours of operation, is hereby amended as follows:

Commercial soliciting and peddling shall be limited to the following hours: Monday through Friday between the hours of 9:00 a.m. and sundown in residential areas, and during regular business hours in commercial areas. Charitable soliciting shall be limited to between the hours of 9:00 a.m. and 9:00 p.m.

SEVERABILITY. Should any section or provision of this Ordinance be declared by a Court of Competent Jurisdiction to be invalid, such decision shall not affect the validity of this Ordinance as a whole, or of any other part hereof.

SECTION 3. That Section 175-31, Schedule XVI (175-91) of Ordinance No. 1960 be and the same is amended and supplemented so as to establish a "NO PARKING AT ALL TIMES" restriction on the following roadway:

- a) On Brookline Blvd., south side, from southeast side of the exit for Brookline Parking Lot to a point 42 feet thereof.

SECTION 4. That Section 175-31, Schedule XX (175-95) of Ordinance No. 1960 be and same is amended and supplemented so as to establish a "HANDICAPPED PARKING ONLY" on the zone restriction on the following roadway:

- a) 601 Georges Lane, one space in front of residential dwelling.

SECTION 5. Upon effective date of this ordinance, the Highway Department shall install appropriate signs in the said sections or zones giving notice of the regulations aforesaid.

AN ORDINANCE OF THE TOWNSHIP OF HAVERFORD, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, AMENDING AND SUPPLEMENTING ORDINANCE NO. 1960, ADOPTED JUNE 30, 1986 AND KNOWN AS THE "GENERAL LAWS OF THE TOWNSHIP OF HAVERFORD", AMENDING CHAPTER 47, AMUSEMENTS AND ENTERTAINMENTS, BY THE ADDITION OF CERTAIN CONDITIONS.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Haverford, County of Delaware, Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same that:

ARTICLE 1. CIRCUSES AND CARNIVALS

Ordinance 1960, Chapter 47, Amusements and Entertainments, Article II, Circuses and Carnivals, Section 47-10, is hereby deleted and the following inserted in lieu thereof:

47-10. Operational regulations.

- A. License fees shall not be assessed to any organization or company of citizens of the Township of Haverford properly representing to the Chief of Police that the net proceeds of such entertainment shall be exclusively devoted to religious, educational, civic or charitable purposes within said township and, in addition thereto, shall deposit with the Township Treasury the further sum of two hundred dollars (\$200.00) to be returned to them upon satisfactory evidence that the net proceeds of said entertainment shall have been or will be appropriated to a religious, educational, civic or charitable purpose in the Township of Haverford.
- B. Hereafter, any applicant for a license to permit exhibitions and entertainment as detailed in Section 47-9.A, shall be required to show proof of ample off-street parking facilities to accommodate anticipated vehicular traffic of exhibition or entertainment patrons. Adequate off-street parking shall be defined as providing one (1) off-street parking space for every fifty (50) square feet of lot or building space devoted to such use.
- C. No outdoor theatrical exhibition, menagerie, circus performance or any outdoor show, carnival, exhibition or performance shall be permitted to operate after 10:00 PM on Sunday through Thursday, or after 12:00 midnight on Friday or Saturday.

- D. Any exhibition or entertainment as detailed in Section 47-9.A, shall employ or retain adequate security personnel, as determined by the Chief of Police.
- E. Any exhibition or entertainment as detailed in Section 47-9.A, shall employ or retain adequate traffic control personnel, to direct traffic and safely cross patrons over any major road, as determined by the Chief of Police.
- F. It shall be unlawful to permit the use of sound amplification equipment at an exhibition or entertainment detailed in Section 47-9.A which is located within 1000 feet of a residential district.

ARTICLE 2. SEVERABILITY

Should any section or provision of this ordinance be declared by a Court of competent jurisdiction to be invalid, such decision shall not affect the validity of this Ordinance as a whole.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Haverford, County of Delaware, Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same that Ordinance No. 1960, Chapter 182 is hereby amended as follows:

ARTICLE 7. SUPPLEMENTAL REGULATIONS

Section 725. Continuing care facilities for the elderly., subsection A. (2) is hereby amended to read as follows:

- (2) The maximum gross density for continuing care facilities for the elderly shall not exceed six (6) units per acre. The permitted number of dwelling units shall be based upon the sum of all residential units and personal-care beds. Skilled-nursing-care beds shall not be counted toward the total number of permitted dwelling units.

ARTICLE 7. SEVERABILITY

Should any section or provision of this Ordinance be declared by a Court of competent jurisdiction to be invalid, such decision shall not affect the validity of this ordinance as a whole.

SECTION 1. That Section 175-28, Article III, para. C. of Ordinance No. 1960 be and the same is hereby amended and supplemented so as to establish "PARKING OF COMMERCIAL VEHICLES PROHIBITED AT ALL TIMES, TRUCKS UNDER 8,000 LBS. PERMITTED" restriction on the following roadway:

- a) Johnson Road, both sides, entire length.

SECTION 2. That Section 175-11, Schedule V, (175-80) of Ordinance No. 1960 be the same is hereby amended and supplemented so as to establish a "PROHIBITED TURNS AT INTERSECTIONS" restriction on the following roadway:

- a) Access road to industrial park travelling east, no left turn, at the intersection of Hillcrest Avenue.

SECTION 3. That Section 175-27, Schedule XVI (175-91) of Ordinance No. 1960 be and the same is hereby amended and supplemented so as to establish a "PARKING OF ALL VEHICLES PROHIBITED AT ALL TIMES, EXCEPT SUNDAY AND HOLIDAYS" restriction on the following roadway:

- a) On West Chester Pike, north side, Trinity Lutheran Church, 1141 West Chester Pike.

SECTION 4. ARTICLE VI On-Highway Metered Parking, Section 175-50 Parking Meter Rates, A., B., and C. is hereby deleted and the following inserted in lieu thereof.

- A. Two hour maximum meters shall accept .05 cents for 1/2 hour; .10 cents for 1 hour; .25 cents for 2 hours of parking.
- B. Ten hour maximum meters shall accept .05 cents for 1/2 hour; .10 cents for 1 hour; .25 cents for 2 hours of parking.

SECTION 5. ARTICLE VII Off-Highway Metered Parking, Section 175-51 Administration: rules and regulations, E. is hereby deleted and the following inserted in lieu thereof.

E. Tractors and trailers of any kind and trucks whose capacity is in excess of 8,000 pounds gross registered weight shall not be permitted to park or be operated on a public off-highway parking place or lot; provided, however that it shall be lawful for commercial trucks not exceeding 8,000 pounds gross registered vehicle weight which are owned and operated by residents of Haverford Township with valid trade licenses in the township to park said commercial trucks in township owned public metered off-street parking places and lots between the hours of 6:00 p.m. and 8:00 a.m. Monday through Saturday and all day Sunday under the following conditions:

- (1) A charge of \$15.00 per month shall be collected by the township for the privilege of parking said commercial vehicles on township owned public metered off-street parking places and lots. Fees to be collected, and stickers to be issued by the records office at the Police Department.
- (2) No commercial business shall be permitted to park more than one vehicle on the aforementioned lots.

SECTION 6. ARTICLE VII Off-Highway Metered parking, Section 175-54 Hours of Parking, B. Twenty-four hour parking. (1) and (2) is hereby deleted and the following inserted in lieu thereof.

- (1) Twenty-four hour fee parking on a monthly basis of vehicles permitted to be parked on public off-highway parking places or lots shall be permitted, provided a twenty-four hour parking permit is displayed on the rear bumper of the vehicle.
- (2) Any person wishing to avail himself of the twenty-four hour parking privilege for any monthly period shall apply to the Chief of Police and upon payment of the sum of \$15.00 in advance shall receive a receipt and a twenty-four hour parking permit, numbered and signed by the Chief of Police, and indicating the license number and owner of the vehicle to be parked and the monthly period for which it is valid. No refund or apportionment is permitted. A record of all permits issued shall be maintained by the Chief of Police.

SECTION 7. ARTICLE VII Off-Highway Metered Parking, Section 175-55 Parking charges. A. and B. is hereby deleted and the following inserted in lieu thereof.

A. Parking is permitted on a public off-highway parking place or lot for any period from one to ten hours, provided that at the time of first parking, the parking as indicated below is deposited in the parking meter at the time of parking for the number of hours proposed to be parked in the manner prescribed in §175-44 of Article VI. Such parking meter rates shall be as follows: All meters in the Oakmont and Brookline municipal parking lots shall be timed for the following monies. - .05 cents 1/2 hour; .10 cents 1 hour; .25 cents 2 and 1/2 hours. All other township owned parking meters shall either be marked as two hour or ten hour maximum meters and shall accept .05 cents for 1/2 hour; .10 cents for 1 hour and .25 cents for two hours of metered parking.

- B.. There shall be no charge for parking between the hours of 6:00 p.m. and 8:00 a.m., except for the charge made in the cases of twenty-four hour fee parking on a monthly basis.
- C. There shall be no charge for parking in a metered parking place on a Sunday or on a National Holiday.

SECTION 8. Upon effective date of this ordinance, the Highway Department shall install appropriate signs in the said sections or zones giving notice of the regulations aforesaid.

SECTION 9. Any ordinance or part of ordinance to the extent that it is inconsistent herewith is hereby repealed.

SECTION 1. The "General Laws of the Township of Haverford" Ordinance No. 1960, Chapter 4, Administration of Government, shall be amended to wit:

- A. ARTICLE X, FISCAL AFFAIRS, Section 4-1008,
Establishment of Purchasing System, paragraph D. shall
be amended in its entirety to read as follows:

The Township Manager shall have the authority to execute purchases and contract with a value of less than (\$10,000.). Purchases and contracts with a value from ten thousand (\$10,000.) to less than fifty thousand (\$50,000.) can be authorized by the Township Manager without the formal bid process, if approved by public vote of the Board of Commissioners. All purchases and contracts with a value of fifty thousand dollars (\$50,000.) or more must be made through the competitive bidding process, except where specifically stated otherwise in the Charter or Administrative Code.

SECTION 2. Any ordinance or part of ordinance to the extent that it is inconsistent herewith is hereby repealed.

AN ORDINANCE OF THE TOWNSHIP OF HAVERFORD, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, AMENDING AND SUPPLEMENTING ORDINANCE NO. 1960, ADOPTED JUNE 30, 1986, AND KNOWN AS THE "GENERAL LAWS OF THE TOWNSHIP OF HAVERFORD" FURTHER AMENDING CHAPTER 132, PLUMBING, BY UPDATING SPECIFICATIONS.

BE IT ENACTED AND ORDAINED by the Board of Commissioners of the Township of Haverford, County of Delaware, Commonwealth of Pennsylvania, and it is hereby enacted and ordained by the authority of the same that:

ARTICLE 1. REGISTRATION OF PLUMBERS

Chapter 132, Section 132-3, **Registration of plumbers required; master and journeyman plumbers; issuance of permit**, is hereby amended to read as follows:

132-3. Registration of plumbers required; master and journeyman plumbers; issuance of permit.

No person, firm, partnership or corporation shall engage in or carry on the business of plumbing or house drainage in the Township of Haverford without first being registered as a plumber by the Department of Codes Enforcement of said township.

A. Master and journeyman plumbers.

- (1) A master plumber shall be the head or the designated proper representative of a plumbing business, partnership or firm, shall have been a plumber for at least forty-eight (48) months and shall either have taken and passed the master plumbers' examination given by Upper Darby Township or by the Delaware County Municipalities Regional Cooperation Council, Regional Examination Board, or shall produce satisfactory evidence to the plumbing code official and Director of Code Enforcement that he has been registered as a master plumber in any testing municipality in the Commonwealth of Pennsylvania.
- (2) A journeyman plumber shall be a plumber, other than an apprentice plumber, who is not a master plumber but does his own work under the supervision of a master plumber. A journeyman plumber shall have been a plumber for at least forty-eight (48) months.

- B. No plumbing permit or permit to do plumbing work shall be issued except upon proper application by a master plumber registered in accordance with the provisions of this section.

ARTICLE 2. CHANGE OF ADDRESS; SURRENDER OF LICENSE UPON RETIREMENT

Chapter 132, Section 132-6, **Notification of change of address required; surrender of license upon retirement**, is hereby amended to read as follows:

- 132-6. Notification of change of address required; surrender of license upon retirement.

Every registered plumber, firm or corporation shall give immediate notice of any change in the location of his or their place of business and, upon his or their retirement from business, shall surrender his or their license to the Department of Code Enforcement.

ARTICLE 3. FEE FOR FILING VERTICAL DRAWINGS AND GROUND PLANS

Chapter 132, Section 132-10, **Fee for filing vertical drawings and ground plans**, is hereby deleted in its entirety.

ARTICLE 4. SPECIFICATIONS FOR PIPES

Chapter 132, Section 132-18, **Specifications for pipes**, subsection A, is hereby amended to read as follows:

- A. All cast-iron, wrought iron or service weight pipe must be sound, free from hole and when laid underground, shall have a uniform thickness of one-fourth (1/4) of an inch.

ARTICLE 5. SPECIFICATIONS FOR PIPE FITTINGS

Chapter 132, Section 132-19, **Specifications for pipe fittings**, is hereby amended to read as follows:

- 132-19. Specifications for pipe fittings.

Fittings for waste or soil pipes shall be service weight or heavy cast iron with bell and spigot drainage fittings. Fittings for vent pipes or wrought iron or steel may be standard cast or malleable steam or water pipe fittings. All fittings must be galvanized and have smooth interior waterways. No-hub fittings may be used above grade.

ARTICLE 6. LEAD WASTE PIPES

(4) Conditional Uses. In any C-4 District, land, buildings or premises may be occupied by the following as a conditional use upon application and approval by the Board of Commissioners:

(a) Tourist, rooming or boardinghouses, subject to full compliance with all applicable off-street parking, buffering and design standards contained in Sections 707 and 718 of this chapter.

 - (b) The installation and/or construction of satellite dishes, earth station satellites and television satellites, provided any such facility is screened from view of any adjacent property owner or from a public right-of-way.
- (4) Conditional uses. In any C-5 District, land, buildings or premises may be occupied by the following conditional uses upon application and approval of the Board of Commissioners in accordance with Article XII:
- (a) Landfills, including sanitary landfills, when operated by a municipal authority or by a municipality.
 - (b) Utility uses, other than satellites.

2. If a motor vehicle or combination for which there is no valid registration or for which the registration is suspended for failing to maintain financial responsibility, or where no financial responsibility has been secured, as verified by an appropriate law enforcement officer, is operated on a highway or trafficway of this Commonwealth the motor vehicle or combination shall be immobilized by the law enforcement authority and the appropriate judicial authority shall be so notified.

3. Police officers enforcing these provisions will follow the guidelines provided by Title 75, Pennsylvania Motor Vehicle Code, Section 6309.2.

SECTION 10. Upon effective date of this ordinance, the Highway Department shall install appropriate signs in the said sections or zones giving notice of the regulations aforesaid.

SECTION 11. Any ordinance or part of ordinance to the extent that it is inconsistent herewith is hereby repealed.

These general goals include, among others, the specific enforcement of the various regulations promulgated by the Delaware County Regional Water Quality Control Authority (DELCORA), the United States Environmental Protection Agency (USEPA), the Pennsylvania Department of Environmental Protection (PADEP), and such other agencies which may succeed the aforementioned agencies to implement the Delaware County Wastewater Management Plan and the National Pretreatment Standards, 40 Code of Federal Regulations (CFR) 401 et seq.

SECTION 2. AMENDMENTS TO REGULATIONS

The DELCORA Standards, Rules and Regulations, adopted by the Township of Haverford, Ordinance No. 2122, as the Township of Haverford's Wastewater Treatment Regulations are amended as provided by DELCORA Resolutions No. 95-06 and 95-12 which are attached hereto, made a part hereof, and identified as Exhibits "A" and "B" respectively.

SECTION 3. LOCAL LIMITATIONS

The Eastern Area Local Limitations for discharge of wastewater as provided by DELCORA Resolution 91-04, which is attached hereto, made a part hereof, and identified as Exhibit "C" are adopted as the Local Limitations for all discharges of wastewater within the Township of Haverford.

AN ORDINANCE OF THE TOWNSHIP OF HAVERFORD, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, AMENDING ORDINANCE NO. 818 AND ORDINANCE NO. 1796, AS FURTHER AMENDED, FIXING THE ANNUAL SEWER RENTAL OR CHARGE TO EACH PROPERTY CONNECTED TO THE SEWER FOR EACH ONE THOUSAND GALLONS OF WATER CONSUMED AND ESTABLISHING PENALTIES FOR VIOLATIONS THEREOF.

BE IT ENACTED AND ORDAINED by the Board of Commissioners, County of Delaware, Commonwealth of Pennsylvania, and it is enacted and ordained by the authority of the same that:

SECTION 1. The total amount of the annual sewer rental or charge for the year 1997 to be required is hereby determined to be \$4,081,652 pursuant to and as part of the Budget Adoption procedures of the Home Rule Charter.

SECTION 2. The Board of Commissioners does hereby determine Two Dollars and fifty cents (\$2.50) per one thousand (1,000) gallons of water used by properties connected with the sewage of the Township as the amount of money to be charged to each property connected to the Township Sewer System for the sewer rental or charge for 1997.

SECTION 3. The sewer rent or charge for the year 1997 for each property within the Township of Haverford using the sewer system and facilities of the Township shall be charged at the rate of \$0.00250 per gallons for water consumed or used by said property.

SECTION 4. A two percent (2%) discount shall be allowed if the bill is paid on or before sixty (60) days from the date of the bills. The face amount of all final bills shall be payable on or before one hundred and twenty (120) days from the date of the bills if discount period is disregarded. All sewer rental charges shall be a lien against the property serviced by the sewer facilities of the Township until said sewer rental charges are paid. Failure on the part of the Township to remit a bill due to administrative error or federal postal delivery problems does not exonerate the property owner from paying the sewer rental fee and penalties imposed. It shall be the duty of the Director of Finance to certify to the Township Manager/Secretary the date that all bills are mailed. If said bills are not paid on or before one hundred and twenty (120) days from the date of the bill, a penalty of ten percent (10%) shall be added. It shall be the duty of the Director of Finance during or after the twelfth month following the month in which bills were mailed to certify the unpaid bills to the Township Solicitor, who shall proceed to collect such delinquent sewer rental together with penalties and costs accrued thereon in addition to attorneys' fee pursuant to Act 1, Commonwealth of Pennsylvania, February 2, 1996 either by action at laws, or by filing a lien or liens for the same in the Office of Judicial Support of the Court of Common Pleas of Delaware County, Pennsylvania, and such liens, together with penalty and costs accrued thereon in addition to attorneys' fee shall be filed and collected in accordance with law. All sewer rentals not paid prior to the date on which penalty shall be added as herein provided shall be deemed to be delinquent.

SECTION 5. Any ordinance or part of ordinance to the extent that it is inconsistent herewith is hereby repealed.
